Background

This memorandum accompanies the City of Baltimore Mayor's Office of Recovery Program's submission of its monthly report to the City Council on spending and performance related to American Rescue Plan Act (ARPA) funding. Specifically, Council Bill 21-0121 § 49-2(B) prescribes the elements of legislatively required reporting, which stipulates that monthly reports should:

- 1) Provide data and metrics regarding how the funds have:
 - I. Increased the effectiveness of city government services;
 - II. Broadened the reach of city government services;
 - III. Made city government services more efficient;
 - IV. Made city government services more sustainable
- 2) Identify key performance indicators, benchmarks, and targets related to:
 - I. Equity, as defined in Article 1, § 39-1 of the Baltimore City Code;
 - II. Population Growth;
 - III. Labor and Employment;
 - IV. Economic Growth, especially the growth of minority and women-owned businesses; and,
 - V. Community Benefit

Commitments and Expenditures

As of the end of March 2022, the Mayor's Office of Recovery Programs has committed \$465.3 million in ARPA funds to several City and quasi-government agencies to support various projects and initiatives for the benefit of Baltimore City residents. When compared to total funding commitments, about 4.3 percent of the total amount of the city's \$641M ARPA allocation has been expended. Through March 2022, about \$27.7 million dollars has been spent for ARPA-funded projects (See Table 1). Please note, the first grant agreements awarding funds for ARPA projects were approved on a rolling basis beginning in November 2021. As such, many awarded agencies are still in program design—which includes scope, selecting community-based organizations for which to partner, and executing grant agreements and/or contracts. More detailed information on expenditures can be found in the expenditures section of the report.

Health Department Expenditures

The Baltimore City Health Department (BCHD) is continuing its robust response to the COVID-19 public health emergency. BCHD continues to fund its COVID-19 response efforts through reimbursement from the Federal Emergency Management Agency (FEMA). In March 2022, President Biden extended federal reimbursement through FEMA's Public Assistance Program for eligible

costs associated with ongoing COVID-19 recovery efforts through July 1, 2022. From July 1, 2022, through December 30, 2022, the cost share will shift from 100% to 90%. Accordingly, the agency is currently using ARPA funding for uses ineligible for FEMA reimbursement, such as contract tracing personnel. Costs related to contract tracing will be updated as soon this data posts to the City's accounting system of record.

Performance Measures and Metrics

The U.S. Department of Treasury requires that grant recipients provide mandatory performance data for certain uses of funds. ¹ In addition, the Mayor's Office of Recovery Programs coordinated with funded agencies and organizations to develop performance measures to monitor the use of ARPA funds and to provide context for how ARPA-funded programs and initiatives are benefiting Baltimore City residents. As previously noted, many agencies are still fully designing and implementing programs, therefore data are limited. Additional data on performance measures will be included in Council reports as programs are further implemented and data are available. The Recovery Office anticipates including some targets and benchmarks for agency performance during the FY23 period of performance. In the interim, the report includes narrative information on agency accomplishments to date.

Equity

The Scott Administration, including the Mayor's Office of Recovery Programs recognizes the opportunity to use one-time ARPA funding to advance equity in Baltimore City. Accordingly, the Recovery Office has designed an application process that considers equity at multiple points: equity has the highest weight in the scoring rubric; we ask, "How will this project incorporate and advance equity?"; and our communications materials make clear that projects in Qualified Census Tracts will be given priority.

Applications: There are 3 ways that the Recovery Office is advancing equity during this stage.

First, we ask applicants to complete an equity assessment, answering prompts like, "How will the project mitigate or decrease existing or historical disparities?" and "Identify, with data and statistics, the population that will be served by this project."

Secondly, we may require organizations to develop equity-based eligibility or prioritization criteria to ensure that funds are targeted to groups with the most need. For example, the Economic Recovery Fund must prioritize applicants that meet the following criteria:

- The applicant has not received prior funding from local, state, or federal COVID-19 relief program such as the Paycheck Protection Program or the Economic Injury Disaster Loan Program
- The organization is located in a Qualified Census Tract* in Baltimore City
- Organizations that provide services such as assistance with food, housing, and other basic needs; employment programs for people with barriers to employment who faced negative economic impacts from the pandemic (such as residents of low-income neighborhoods, minorities, disconnected youth, the unemployed,

- returning citizens, veterans, and people with disabilities); and other organizations that provide disadvantaged groups with access to education, jobs, and opportunity.
- MBE/WBE/DBE/Veteran or other economically disadvantaged qualification from the City, State, or Federal Government
- The organization employs 50 percent or more of Baltimore City Residents as W2 employees
- Organization with 20 or fewer full-time employees

Lastly, we require organizations to develop performance measures and then specify whether the data can be collected and disaggregated by demographic characteristics: Age, Gender, Race, Ethnicity, ZIP Code, Income Level, Sexual Orientation, or Gender Identity.

Funded Projects: The Recovery Office requires funded organizations to collect specific performance measures by demographic characteristics as part of monthly and quarterly reporting to the extent possible. The Recovery Office is also coordinating with our university partners to leverage reports and other research such as Baltimore Community Change 2010-2020 and the Equity Analysis of Baltimore City's Capital Improvement Plan, FY2014-FY 2020 to inform our equity approach. In addition, the Recovery Office is leveraging this information to connect ARPA investments to specific ZIP codes and neighborhoods. An example of such efforts can be found in the Economic Recovery Fund section of the report.

Population, Labor & Employment Growth

Council legislation requires key performance indicators, benchmarks, and targets related to population growth. No data source exists that would demonstrate population growth on a monthly basis. In addition, the Mayor's Office of Recovery Programs is responsible for administering American Rescue Plan Act funds and ensuring these funds align with allowable uses under the law. Accordingly, some funding may be used for programs and initiatives that could result in population growth. However, such instances would be anecdotal in nature, and cannot be positively correlated to ARPA expenditures.

The Mayor's Office of Recovery Programs has awarded ARPA funding for significant investments into small businesses, and non-profits with a prioritization on minority and women-led organizations. As previously noted, data are limited as programs are being implemented. The results of efforts to date are included in the Economic Recovery Fund portion of the report.

The Mayor's Office of Recovery Programs continues to make significant progress in the awarding of ARPA funds, the monitoring of agency and organization's progress, and in the accountability and transparency in the use of these funds. Information on awards, reports and our public-facing dashboard can be found at arp.baltimorecity.gov.

Expenditures

Table 1 lists ARPA expenditures through the month of March 2022, totaling \$27,726,228.² These expenditures are associated with project account numbers as documented in the general ledger.

Recovery Office Accomplishments

Since the last report, the Mayor's Office of Recovery Programs announced a \$4.8 million dollar funding commitment to launch the Baltimore Young Families Success Fund. The Baltimore Young Families Success Fund is a Guaranteed Income pilot project that will provide 200 young parents, between 18-and 24 years old, with an unconditional cash payment of \$1,000 per month over the course of 24 months. The Baltimore Young Families Success Fund is a part of a cohort of 62 evidence-based guaranteed income pilots across the country.

In addition to funding commitments, the Mayor's Office of Recovery Programs has employed robust monitoring measures, including holding monthly meetings with funded agencies to review expenditure data and performance data and to learn of any project developments such as community engagement activities, contract award plans, and BOE agenda submissions.

The Recovery Office continues to develop communication tools to provide factual and practical information on the use of ARPA funds and its impact on the community. In April 2022, the Recovery Office issued its first ARPA Insights newsletter, which features two recipients of the Childcare Stability Grant, administered in partnership with the Family League (See Appendix).

Subawardee Accomplishments

COVID-19 Health Response

The Baltimore City Health Department (BCHD) is actively working to prepare its existing contracts related to testing, vaccinations, food insecurity, and other functions (except for Contact Tracing) to be partially charged to ARPA-funded accounts (from FEMA reimbursement) in July. In addition

to the ongoing work to transfer its contact tracing positions to Grant Service Specialist (GSS) positions, BCHD has begun transitioning its other contractor positions previously funded by FEMA to GSS positions. BCHD is also in the process of posting and hiring for several operations support positions. Lastly, BCHD is nearing completion of its lease agreement for a PPE Warehouse that will be shared with the Baltimore City Fire Department.

Baltimore Civic Fund Economic Recovery Assistance

BCF continued to support grantees with accessing reimbursement payments. Since the last report, BCF provided an additional 80 grants totaling \$2,227,249 (See Table 2). BCF also continued developing materials to support the announcement of the Request for Proposals for 2022 Baltimore Nonprofit Relief Fund. BCF also selected a cohort for "Endurance Baltimore," which is BCF's ARPA-funded technical assistance program for nonprofit awardees. Two cohorts of ten nonprofits will participate in a 90-day program that will help nonprofits build the tools necessary for financial resiliency. Activities and resources involve scenario planning, financial cash flow models, operational plans, new revenue strategies, group sessions, and one-on-one coaching sessions.

Baltimore Development Corporation Economic Recovery Assistance

BDC notified nearly 730 applicants of the results of their grant applications. Of those applicants, 221 (30 percent) were awarded grants totaling \$4.8 million. Among the awardees, 88% are BIPOCowned businesses and 77% are women-owned businesses. Information on specific organizations receiving grant awards will be updated once disbursements are completed.

Visit Baltimore Economic Recovery Assistance

Visit Baltimore has completely expended its \$2.5 million grant award to date. Thirty-seven hotels received a total of \$2,350,002 dollars, and Visit Baltimore reported \$149,998 in administrative expenses. The average award was \$63,513.57.

Baltimore Office of Promotion and the Arts Recovery Assistance

Grant applications closed on March 18, and BOPA is currently conducting a panel review of all applications, which are anticipated to be completed by April 28, 2022. BOPA plans to begin notifying grantees of their awards and disbursing funds in May 2022. BOPA estimates that it will make 112 awards, at \$3,500 each to individual artists.

Family League Economic Recovery Assistance

FLBC has committed and disbursed all funding to eligible applicants. On April 14, 2022, the Mayor's Office of Recovery Programs issued its first ARPA Insights communication featuring recipients of the Childcare Stability Grant.

Mayor's Office of Broadband and Digital Equity (MOBDE)

MOBDE hired a lead project manager who is now engaging with both the technical planning and procurement to support roll-out of public Wi-Fi hotspots, fiber connections to select recreation centers, and planning for major broadband infrastructure projects.

MOBDE has continued its collaboration with the Office of Performance and Innovation, which is supporting community engagement efforts and providing input into design considerations for public Wi-Fi service.

MOBDE has refined the initial list of Wi-Fi hotspot locations for initial deployment and will begin procurement to support initial roll outs at key locations. These initial deployments are intended to support continued community engagement as well as small-scale technology evaluation.

Mayor's Office of Neighborhood Safety and Engagement (MONSE)

In mid-March, MONSE announced it will collaborate with the Baltimore City Department of Housing and Community Development to implement one of the components of the Neighborhood Policing Plans, as identified in Mayor Scott's Comprehensive Violence Prevention Plan. Through environmental design efforts, this pilot led by residents will reimagine and repurpose vacant spaces in ways that best serve the respective community.

Mayor's Office of Employment Development (MOED)

In March and early April of 2022, BOE approved 11 Train Up training provider agreements, 7 funded by the State ARPA grant and 4 by the City ARPA grant. Currently, just one of the 18 agreements with 17 organizations is awaiting approval. MOED anticipates the final agreement will reach BOE in May. In March, three Community Connectors were selected as part of Train Up, with BOE approval expected in June. The agreement with Train Up's adult education provider received BOE approval on April 20, 2022. On April 6, BOE approved the subgrant agreement with Maryland Legal Services Corporation (MSLC), enabling MLSC to move ahead with subcontracts with two competitively selected providers that will offer legal services to all Hire Up and Train Up participants. The RFP for Train Up/Hire Up behavioral health services closed in March, and the selection panel approved funding for one organization to offer these services.

Hire Up added three new worksite partners during the reporting period, bringing the total number of City agencies and nonprofits to nine, including MOED. The agency has enough available positions to sustain Hire Up at the level budgeted in its City ARPA proposal. The program is currently funded by a State RELIEF Act grant. Funding for Hire Up will shift to the City ARPA grant once RELIEF funds are fully obligated.

The Small Business Wage Subsidy program received its first seven requests for reimbursement from qualified businesses in March. The first subsidies will be paid for by the State ARPA grant, with City ARPA grant funding expected to activate in early summer for the remaining subsidies.

Finally, MOED has enrolled 72 young people into the YouthWorks Academy. This job readiness program for YouthWorks applicants started in February and runs through May 2022. It is intended to prepare young people to obtain YouthWorks positions with private sector employers during the summer YouthWorks program. The application deadline for the YouthWorks summer program was extended from April 1, 2022, to April 15, 2022. The five-week summer jobs program runs July 5 to August 5.




Figure 1: Organizations Funded by the Economic Recovery Fund

Introducing ARPA Insight Stories

The American Rescue Plan Act (ARPA) provided \$641 million to the City of Baltimore in response to the COVID-19 public health emergency and its negative economic impacts. Mayor Brandon M. Scott established the Mayor's Office of Recovery Programs to transparently and effectively administer this funding on behalf of the City. Since July 2021, Mayor Brandon M. Scott has allocated over \$450 million in American Rescue Plan Act (ARPA) funds. **ARPA Insight Stories** will share the impact of funded programs through this office. COVID-19 Childcare Stability Grant

In the wake of the COVID-19 public health emergency, many childcare providers are closing their programs—unable to sustain operations with diminishing enrollment. Other providers are staying open despite the physical risk, to support the needs of working families in their community. The childcare workforce, 40% of which are minorities and almost entirely female, lost more than 150,000 jobs by the end of 2020.

In November 2021, Mayor Brandon M. Scott allocated \$2 million to Family League of Baltimore (Family League) to execute the Childcare COVID-19 Stability Grant through the ARPA-funded Economic Recovery Fund. Family League disbursed these funds to 182 childcare providers impacted by the COVID-19 public health emergency. The grant was established to supplement childcare centers that, in many instances, already operate on thin profit margins and struggle to provide quality services given the requirement to maintain a safe environment and appropriately sized workforce for the safety of the children in their care during the COVID-19 public health emergency.

As of November 2019, regulated early care and education, including public pre-kindergarten programs, was available for approximately 48% of the city's children under the age of five but only 12% of infants under the age of 2 (2020 Baltimore Early Childhood Care and Education Report). The negative economic impacts of the COVID-19 public health emergency have only exacerbated these numbers. According to Childcarerelief.org, many childcare providers went out of business months into government-mandated shutdowns and others were forced to shut their doors due to increased operating costs and reduced enrollment revenue.

The impact of ARPA funding stretches beyond the childcare providers and the children they serve. This funding is essential in recovering Baltimore's economy from COVID-19 by giving parents and guardians an opportunity to return to work while ensuring their children have safe, licensed care. This newsletter will allow you to meet some of the childcare providers that received ARPA funding and are dedicated to nurturing Baltimore's future.

Meet La-Faye Connor and Lisa Brooks

La-Faye Conner and Lisa Brooks have over 50 years of combined childcare experience. Together, they run Shining Stars Childcare Center in Southwest Baltimore serving children from 2 months old to 12 years old. They applied for the Childcare Stability Grant to assist with payroll, personal protection equipment, and cleaning supplies that assist with cleaning and social distancing protocols. Before the COVID-19 public health emergency, Shining Stars provided care to 22 children. Currently, they serve about 7-8 children and their families. The Childcare Stability Grant allowed for Brooks and Connor to pay staff despite decreases in enrollment. The grant also allowed them to subsidize tuition at the childcare center so that low-income parents did not have to pay out of pocket for childcare costs. "We do it for the children and the families," Brooks said. "Parents need to get to work. And they need experienced professionals who can care for their children while they are there. This grant allows our doors to stay open and help the families who need it most."

Meet Martina Johnson

Martina Johnson has been running Tina Tot's Childcare, a family childcare center, since 2010. Her childcare center has felt the trickle-down effects the COVID-19 public health emergency is having on the families she serves. Parents were unable to pay tuition timely, so bills became a juggling act.

Despite challenges, Johnson has been able to maintain her enrollment levels and serve the same families throughout the pandemic. Her ability to maintain these relationships with her families and students speaks to the importance of childcare providers and how closely interwoven they are with the fabric of our communities.

Johnson described the grant as a "security blanket" and one of the best things that could have happened to her childcare center. As places for recreation became limited through the COVID-19 public health emergency, the importance to have on-site recreation activities became even more important. Johnson used the ARPA funds she received to purchase a playground for the center.

"The pandemic has brought on some scary and hard times. As a person with pre-existing health conditions, the grant allowed me to purchase the necessary personal protective equipment to keep everyone here safe," said Johnson. "On behalf of all providers, I want to thank Mayor Brandon M. Scott, The Mayor's Office of Recovery Programs, and Family League. We really would not be able to survive without grant opportunities like these."
