New 30-year shingle roofs, double-paned windows, and steel exterior doors will be installed. All environmental hazards such as mold and lead paint will be remediated. Energy efficiency is also a priority for each of the homes, as such obsolete mechanical, electrical and plumbing systems will be replaced to meet current building codes.
